SUBJECT: Sheriff’s Office Duty Pistols

<p>Background: We are requesting to make a second purchase of replacement duty pistols this fiscal year. We have budgeted within this fiscal for replacing our current Glock duty pistols and also our current Tasers. Both of these updates were to be an incremental changeover occurring over the next 3 years. Earlier this year, our Agency was the recipient of an unexpected donation of Tasers from the Oregon State Police. This donation provided UCSO with 25 T7 Tasers, which fully equips UCSO with what we had planned and budgeted to purchase over the next 3 years. With this unexpected windfall, we would like to take advantage of current pricing and availability of the Glock “package” and make a second purchase now. The purchase of 10 more Glocks and holsters is within what was originally budgeted for purchasing Tasers. As with our previous purchase of Glocks, we will receive some “trade-in” value for our current, .40 caliber Glock duty pistols which will help offset the costs of purchasing the new equipment.</p>	<p>( ) ACTION REQUESTED: We respectfully request authorization to purchase (10) ten Glock 45 COA duty pistols and holsters, for a <b>total cost of \$9,470.00</b>.
