SUBJECT: Athena Office Key Fob install

<p>Background: The Sheriff’s office, along with other Umatilla County facilities, has undergone an upgrading to our entry/exit systems. We have installed / upgraded electronic fob entry/exit to most of our facilities. Currently, there are (2) satellite offices, Athena and Weston, which do not have the electronic fob entry / exit system. Uni-tech has provided a quote for the Athena office, which is a higher priority for upgrade currently. The current locking system at the Athena office consists of a number code entry which has been in-place for a number of years. Former employees who previously had access, may still have access via old codes still in the ‘system’.
